We the People

insure domestic Tranquility, provide for the common defence, promote and our Prosperity, all which we establish this Constitution for the United States of America.

Section 1. All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.

Section 2. The House of Representatives shall be composed of Members chosen every second Year by the People of the several States, and the Electors in each State shall have the Qualifications requisite for Electors of the most numerous Branch in that State.

Representatives and direct Taxes shall be apportioned among the several States which shall be determined by adding to the whole Number of free Persons, and three fourths of all other Persons, the actual Number within each State, but such States shall have at least one Representative.

When necessary before the House of Representatives, the House may adjourn from day to day, and may convene in any City within that State.

Section 3. The Senate of the United States shall be composed of two Senators from each State, chosen by the Legislature of the State for six Years, and each Senator shall have the Qualifications requisite for Electors of the most numerous Branch in that State.

Section 4. The Senators and Representatives before mentioned, and the Electors in each State, shall have the Qualifications requisite for Electors of the most numerous Branch in that State.
